The meeting commenced at 7.17 p.m.

Cllr Hyatt opened the meeting to the public by saying the majority of the council had recently attended a Quarry in Ipswich to view first-hand the sound caused by the proposed machinery to be used in Sandon. Sue Dobson then spoke and said she had been to visit the site in Sandon. Sue Dobson then showed the Council a copy of the letter she had written on behalf of residents. Cllr Hyatt said how inaudible the Council had found the machinery. Sue Dobson then said she would send a copy of the letter to the clerk. Sue said the main concern was the number of Lorries (approximately 80) that would be on-site. Cllr Hyatt reported that Bretts are currently revising the planning application in view of the comments raised by the residents and Sandon Parish Council and have promised to circulate this once it is published. Sue Dobson said it works out approximately 220 meters away and how pleased the residents were with the revised plans. Sue Dobson then asked where the bird scarers have been situated. She stated that they start at 7 a.m. in the morning and finish at 7.30 p.m. 2 bangs every 30 minutes and very noisy. Environmental Services should be contacted. Clerk to contact.

- f) Maintenance issues Cllr Calmeyer reported that he had a meeting with Revd. Terry Brown and David Farrar regarding additional grass cutting. It was agreed that SPC would cut the grass 12 times a year, however, they would cut additionally for special circumstances fetes etc. However, in return they will be allowed to use the hire of the church room for free. There followed a discussion regarding the periphery around the field and the frequency of grass cutting by Sandon Parish Council. Cllr Bullus to ensure this is in the lease.
- g) The Howe Green noticeboard has been destroyed by a road traffic accident. Cllr Calmeyer to provide a quotation for a new noticeboard. Clerk to contact the driver of the vehicle for his insurance details.

- n) **Date for Annual Assembly 2017** and invitation to the new Police Commissioner. Clerk to invite the Police Commissioner (Alan Cook).
- o) **Deed of Easement** Cllr Calmeyer updated the council by saying the amendments to the Deed of Easement are with the Solicitor.
- p) **Neighbour Hood Plan Report** Cllr Hyatt reported that she had attended a recent meeting of the RCCE. Plans to create local polices and application plans are difficult not one Essex Council have had their plans passed. Some have been doing this since 2012. It is a very complex process. We would need to follow the same format as Chelmsford (whose plan isn't due out until Christmas). You need a formal voting process in Sandon and the statutory rules for every single aspect are very complex.
- q) A vote was taken to decide whether to proceed with the RCCE. It was unanimously agreed that we would not proceed with this scheme.
- r) RCCE Cllr Cross had chased the secretary for Ed Rigby regarding an update following the recent survey. 120 replies were received from the 650 surveys sent out to Sandon residents. It found we need four or five units of two / three bedroom properties. He has sent us the exact areas where residents would suggest the housing is situated. Cllr Cross is going to go through the map and highlight who owns which fields. A meeting is arranged for Wednesday, 20th July with a developer who wishes to discuss land near the Park and Ride.
