- a) **Howe Green Chapel** –.Cllr Hyatt said that she had circulated the e-mail sent from Revd. Meatcher. It was agreed not to continue to pursue options for the Chapel until Revd. Meatcher has explored all further options.
- b) **Community / Sports Club** Cllr Calmeyer said he was concerned regarding the Sports Club Lease. Cllr Calmeyer and Cllr Bullus to go and visit the Diocese.
