### 040816 Current Issues

- a) **Howe Green Chapel** Cllr Hyatt said the Council are going to discuss Howe Green Chapel with St. Andrews Church following Revd. Meatcher's conversation with Revd. Terry Brown.
- b) **New Appraisal Form** Cllr Hyatt said the Appraisal Form previously circulated by Cllr Hoare was a very useful document. Cllr Bullus said it was a good form and contained lots of information and memory joggers which would prove useful. Proposed by Cllr Bullus and seconded by Cllr Mboyne.
- c) **Grove Farm** The clerk said that a further e-mail and telephone call had been made to chase the letter of agreement. Clerk to continue to chase.
- d) Hall Lane Cllr Calmeyer said that he had been in discussion with Cllr Wright and it appears that the City Council are going to buy Mr Mixture's hut. He has accepted on the condition all his property in the hut, on the car park and WM's Land is removed in 21 days. Cllr Hyatt has also had an email from the Police with a further update.

f) Youth matters – Cllr Mboyne reported the scheme will commence again in September after the school holidays. The scheme focuses on Year 11 Business and Employability Skills. John Lewis opens September 29<sup>th</sup> 2016. Cllr Mboyne will be taking young children around to view the store.

**SuperFast Broadband** – this is an ongoing issue for many residents in Sanodn. From the cabinet to your house you have to either make your own arrangement and have a wireless network or get BT to put the fibre cables in. Less than 750 houses it is not financially viable. SFB were saying for smaller parishes you could get a satellite or wireless and would need to agree as a group and submit the application. It was agreed that the Council would circulate with the next Sandon Topics a copy of the Superfast Broadband Register your demand and keep in touch forms. Phase 2 begins in September and they also have a pot of money from Europe.

The next Sandon Topics will be September / October. Cllr Mboyne will put this information on the Sandon Forum.

g) Maintenance issues – Insurance Company involved in this claim needs to be chased regarding the Howe Green Noticeboard. Lime Trees – Clerk to update the residents on Sandon Place and to approach the diocese.
