17/00137/FUL Outbuilding Wayside Mayes Lane Sandon. Conversion of outbuilding to single dwelling. No observations

17/00157/FUL Rocquaine 34 Chalklands Sandon. Two storey front and rear extension, part single storey front, rear and side extension. No observations

17/00349/FUL Land West Of Chamberlains Farm Sporhams Lane. Proposed construction of a stable block, hardstandings and fencing. Sandon Parish Council object to the application on the grounds that this small area of field has already got at least 6 buildings on it, including 2 stable blocks, with no horses seen for a very long time. Grazing on this property is very limited due to all the buildings that have been placed, therefore could not sustain any further stabling/horses. There are 2 very large barns at the rear of the property which we do not recall receiving planning applications for and they could also contain stabling if further equine accommodation required. This site is already over developed, and as it is on a protected lane, any more stabling would mean increased vehicular traffic and horse boxes which should not be encouraged. There is already a livery yard a very short distance away, and we feel this site is turning into a yard, which we do not feel is appropriate or needed in this area.

17/00319/FUL The Briars Mayes Lane Sandon. Proposed extension (from 20m x 40m to 20m x 60m) to existing manege and installation of a horse walker / exerciser for private use only. No observations

17/00359/FUL. Southlands Farm Southlands Chase. Two storey rear extension and balcony. single storey rear extension with flat roof canopy. New cart lodge and tennis court with perimeter fencing. No observations
