17/01034/FUL. Hillcrest Sporhams Lane Sandon. Amendments to previously approved replacement dwelling and detached carport (15/00890/FUL), with changes to the proposed ground floor windows and doors. No observations

17/01065/FUL. Site At Richmond Southend Road Sandon. Proposed new dwelling and detached garage, with associated access and a pond. Sandon Parish Council object to this application.

DC-4 states 'All development proposals should safeguard the amenities of the occupiers of any nearby properties by ensuring that development would not result in intrusion and the build form would not adversely prejudice the outlook, privacy or light.' Even though this new large 4 bedroom house will be at the bottom of the short gardens of The Croft and Eastern, it will still be very visible and intrusive and will generate extra traffic down the narrow access road, causing more disturbance for The Croft from vehicular traffic.

We feel this is over development of the site, and even though we understand the recent bungalow built in the garden of the house in Chalklands was permitted, we do feel this is different as it did have immediate access onto Southend Road.

We also feel that the field which was home to the family pony is rural land and should not have an ornamental pond put in as it is not an area for recreational use. 2 houses in The Old Orchard and Three Oaks all have fields as part of their properties but have not been permitted to use the land for recreational use - this would set a precedent. This would also be a material change to the use of the land.

17/00006/TPOREQ. Land North And South Of Sandon School Molrams Lane Sandon. Request for a tree preservation order.

17/01111/FUL. The Briars Mayes Lane Sandon. Retention of existing arena lights and addition of 2 no new lights to the arena extension. No observations.

17/01135/FUL. 33 The Lintons Sandon. Single storey rear extension including associated alteration, and conversion of existing garage into playroom and utility spaces. No observations
