21/05017/TPO Ridgeway East Hanningfield Road. T11 Oak/ T12 Oak - crown reduce by 2m - Reason: Tree maintenance. No observations

21/00193/FUL Sunnyside Southend Road. Front dormer No observations

21/00083/FUL Site At Brambles Southend Road. Demolition of existing dwelling. Construction of a new dwelling with integral garage and associated works. Sandon Parish Council disagrees with this application on the following grounds.

- 1. This large, very domineering 5 bedroom house built in the backlands will take away the privacy and amenity of the neighbouring properties. We note it has been set well back on the newly acquired piece of rural land behind the existing property, but it will have a visual impact on at least 6 of the neighbouring properties. Strategic Policy S11 states in 6.85 Any development in the Rural Area must be suitable and compatible with its character, as set out in other relevant policies in the Local Plan. Development will be supported provided it does not adversely impact the identified intrinsic character and beauty of the Rural Area and complies with other relevant policies of the Local Plan as well. This development does not comply with this, as it will have a huge impact on the intrinsic character of the area, which was a grazing field that the local properties looked out upon.
- 2. The dividing hedgerow has been allowed to become very tall trees which does form some screening but will need to be maintained. The application mentions planting new trees in the spaces, but during the winter the neighbours will have a very clear view of the new property.
- 3. The access road is very narrow, and we are very concerned about damage to the houses either side and the amount of traffic for such a large development will cause noise and pollution. Entry from the very busy Southend Road is potentially detrimental to the free flow and safety of traffic on Southend Road.
- 4. We do not see an ecological survey in the paperwork? With a development of this size and on rural land, we would have expected to see one.

This is a backland plot in the Green Belt, where the buildings should not dominate the scene and views of the countryside. The visual impact, scale and siting of such a large development is inappropriate.

Sandon Parish feel this development is too big for the site and situation behind the houses of Southend Road, it is proposed to be built on Green Belt previously used for grazing and therefore this application should be refused.

21/05027/TPO Chilterns East Hanningfield Road. Oak (T13) - crown reduce by 5m; Oak (T14) - crown reduce by 6m; Oak (T15) - crown reduce by 5m - reason: tree maintenance.
