061121 Current Issues.

- (a) Maintenance and ditch clearing Meeting agreed to accept the quote of £2,850 from Andrew Eng for the extension to the Turnpike ditch as well as the clearance of associated vegetation. Meeting agreed to the further clearance of Corner Green recognising that this will cost another c.£14k. Cllr Calmeyer to seek three quotes. Clerk to update local resident that this work may not be completed until Spring 2022
- (b) Allotments Meeting agreed to allow a plot holder to erect a shed 5' x 3' x 6' as long as it was sited at the top edge of the plot (the northern side). A key has been found. Clerk to write to the likely owner alerting him to this fact. Clerk to write to CCC asking for a further update on site's future. Meeting noted that the owner of half plot no 6 has now given it up. This has been reallocated to the other half owner as per our policy.
- (c) Community Centre Meeting noted that the plans have been approved. Cllr Calmeyer to contact the Sports Club so as to organise a steering group. Architect to be approached to put together full building plans. A grant finder may need to be appointed. Clerk to contact Strutt & Parker and update them with developments
