22/01295/FUL Days Cottage, East Hanningfield Road. Two storey side extension. Addition of 3 front roof windows. No observations

22/01437/CUPAQ Phase Two At Mill Hill Farm, East Hanningfield Road. Determination as to whether the prior approval of the local planning authority is required for the proposed change of use of agricultural buildings to 2 dwellings (Class C3). No observations
